NOTIFICATION FOR SPOT COUNSELLING (3rd phase) OF 'M' GROUP CANDIDATES.

This is for information of all concerned that **another phase of SPOT counseling** for M Group will be conducted on **07.01.2021 (Thursday)** to fill up remaining vacant seats of Govt./Govt. ITIs running under PTP. **Numbers of vacant seats are limited.** The criteria of SPOT counseling will be as follows:

New Registration:

1. New candidate's registration window will be opened from **04.01.2021 to 05.01.2021 (Up to 05.00 pm)** for new registration of any other candidates out of the existing merit list.
2. Relevant documents may be uploaded up to **8.00 p.m of 05.01.2021.**
3. However, their merit ranks will start after the last ranked applicants who are already in the published merit panel.

Criteria:

1. **All the vacant seats shall be allotted based on General Rank of the "M" group candidates.**
2. **Merit listed valid candidates** of M Group, who **could not participate in the online counselling OR who have not taken any admission in any seat** are eligible to take admission through SPOT Counselling.
3. Candidates who are debarred from admission for **erroneous percentage of marks** are not eligible to participate in this SPOT counselling.
4. **Candidates, who have already taken admission in any Govt./PPP ITIs through online counselling, are not eligible to participate in this SPOT Counselling.**
5. Seats will be allotted completely on the basis of 'M' Group rank list.
6. Willing eligible candidates must report at the ITIs where he/she wants to take admission (Subject to availability of seats of his/her category) on specified date and time to participate in the SPOT counselling.
7. Candidates must check the vacancies of Seat Matrix on the www.wbscvt.org and sets their priority of ITI during SPOT counselling.
8. Allotment will be done in the vacant seats of ITI strictly on the basis of MERIT.
9. Failure to report at the scheduled date and time will make the candidate ineligible for counselling.
10. **Please note that calling for counselling does not ensure allotment of seats. Allotment of a seat to a valid and eligible rank holder depends on his/her rank and availability of vacant seat at time of his/her turns. SPOT counselling will continue till there will be availability of seats and the counselling will be stopped when all eligible vacant seats will be filled up.**
11. Once a seat is allotted to a candidate through SPOT counselling, the candidate has to pay and get admitted with in midnight of that day, failing of which his/her allotted seats will be cancelled.
12. Allotted seat cannot be changed or cancelled at any circumstances.
13. All the participants are requested to maintain COVID protocol at the counselling venue as per Govt. notification.
14. **Admission date: 07.01.2021 (Within midnight)**

Candidate should bring Rank Card with them at the counselling venue
