Schedule and criteria for the same will be as follows:

7th phases of online counseling:

Schedule: Allotment in the vacant seats will be published through 7th phases of online counseling on **12.11.20** with the choices uploaded by the candidates during 02.11.20 to 05.11.20.

<u>Criteria:</u> <u>Compulsory admission</u> clause for all candidates getting seats in 7th phase Seat Allotment to be published on 12.11.2020.

- a) It is compulsory for the Candidates who are getting seat allotment in 7th phase and subsequent phases to take admission in allotted seats by payment of fees.
- b) If any allotted candidate does not take admission She/he will not get any further seat allotment or chance of choice filling in this year.

<u>Admission Date:</u> Allotted candidates of 7th phase online counseling will have to get themselves admitted between **12.11.2020 to 13.11.2020** by payment of fees.

8th phase of online counseling:

<u>Choice filling:</u> Fresh choice filling will be sought from the willing candidates of **M** group from **15.11.20 to 16.11.20** for filling up remaining vacant seats after 8th phase of counseling.
