**NOTICE**

This is for information of all concerned that afresh choice filling will be conducted from 02.10.21 to 06.10.21 to fill up remaining vacant seats of Govt. /Govt. ITIs running under PTP.

Merit listed valid candidates of M Group, who could not participate in the online counseling in last 03 phases OR did not get any seat in online counseling OR could not take admission even after allotment of a seat due to different reason and having ranks are only eligible for this 4th phase of Counseling.

**Candidates, who have already taken admission in any Govt./Govt. ITIs running underPTP through online counseling, are also eligible to participate in this phase of counseling for trade/ITI up-gradation.**

Candidates can check the vacancies of Seat Matrix on the [www.wbscvt.org](http://www.wbscvt.org) and set their priority of ITI during 4<sup>th</sup> phase of counseling.

**Allotted seat cannot be changed or cancelled at any circumstances.**

However, such candidates are allowed to fill up the choices with the following conditions:—

1. If such admitted candidates get allotment in the upgraded seats as per his/her choice, he/she has to take **admission mandatorily** and the resultant vacancy will be offered to the **next eligible candidate**.
2. If the candidate does not get higher choices, his/her base seat (to which he/she is admitted now) will be retained.
3. If such candidates are up-graded in the same category of seats i.e. Govt. to Govt. he/she need not to pay any admission fees. However, in case of any change of admission category i.e. Govt. to IMC or IMC to IMC (with various combinations) the candidate has to pay the residue amount, as will be mentioned in the allotment letter. If the candidate is upgraded from IMC to Govt., then also he/sheneed not to pay any admission fees. The candidate will be entitled for refund his/her excess admission fees (if any) deposited earlier. The refund will be processed on a

subsequent date after proper verification.

4. **All the M group candidates in the merit list may fill up as much choices as he/she desires. However, seats will be allotted as per available vacancies.**
5. Candidates, who are debarred/suspended from admission for erroneous marks/any other reason, are **not eligible to participate** in this 4th phase of choice filling.
6. **M Group** applicants are also eligible to choose any **E Group** trades of his/her choice. **E group candidates are not eligible for this phase of choice filling.**
7. **There will be No VTC/PBSSD/Women/District quota for this phase of counseling. However other quotas as per prevailing norms will exist.**
8. The selected candidates of the 4<sup>th</sup> phase will have to get themselves admitted between **09.10.2021 to 11.10.2021.**
